

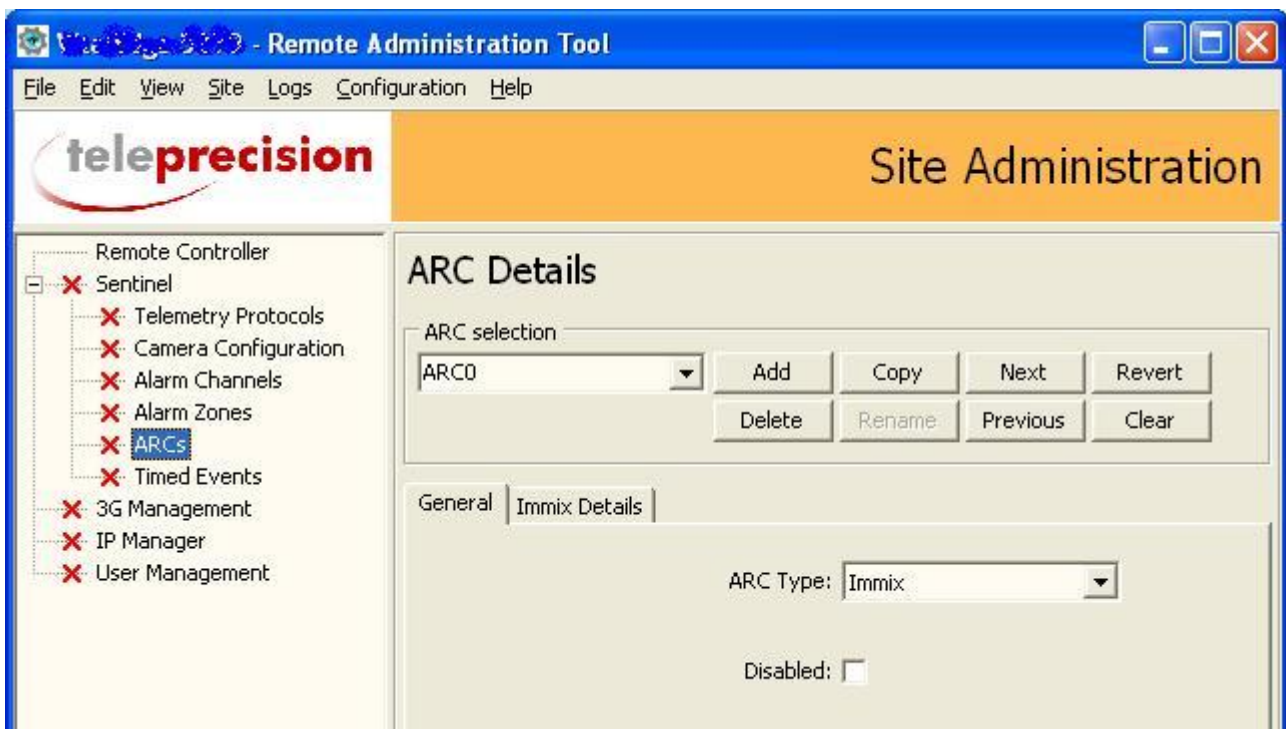


## Technical Note: Alarms To Immix

To configure a unit to send its alarms to a central station which uses the Immix system, you will need the Immix ip address and the site identifier or 'S-number', both are supplied by the central station.

- Connect to the site using the Remote Administration Tool
- Select the 'ARCs' screen and choose 'Immix' from the 'ARC Type' drop down
- Move to the 'Immix' tab and enter the details obtained from the central station
- You may wish to alter the ARC name in the ARC selection section by overtyping and clicking [Rename]. This is optional but can be a useful reminder in the future
- Click [Apply] to commit the changes
